PORAM MANAGEMENT BOARD REPORT FOR THE YEAR ENDING 31ST DECEMBER 2015

A. GENERAL

The 37th Annual General Meeting (AGM) was held on 11th June 2015 at Grand Dorsett Subang Hotel, Selangor Darul Ehsan. Reports on financial performance and activities of the Association were presented to Members for approval. A new Management Board for the office term 2015-2017 was elected at the AGM.

A total of two Board meetings were held in March and June 2015. The Board meetings were convened to receive financial reports, for the Secretariat to apprise the Board on the operations of the Association and to discuss matters and issues arising under the purview of the Board.

A Special Board Meeting was held on 1st July 2015 to discuss the revision of PORAM Rules and Constitution which was raised at the Board meeting in June especially on the eligibility of the appointment of the Management Board Members and its composition. An Extraordinary General Meeting (EGM) was later held on 11th November 2015 to amend the Rules and Constitution of the Association. The revised PORAM Rules and Constitution was approved by the Registrar of Societies (ROS) on 30th December 2015.

B. MARKET REVIEW

The year 2015 saw a mixed performance of the Malaysian palm oil industry vis-à-vis 2014. In terms of total palm oil export market performance, the year 2015 saw a moderate improvement over the previous year. There was a small 1.2% increase in volume from 25.07 million tonnes in 2014 to 25.37 million tonnes in 2015. Despite improved export volume, the total export revenue was much lower by 5.4% from RM63.61 billion in 2014 to RM60.18 billion in 2015. This was mainly due to lower overall export prices for all palm products and subdued demand throughout the year. (See Table 3 and Table 4)

The total oil palm planted area had increased by 250,708 hectares to 5.64 million hectares in 2015. The large increase in planting area was supported by the replanting incentives given by the Government under the National Key Economic Area (NKEA) to accelerate planting of oil palm especially in Sarawak. A total of 4.86 million hectares or 86.1% were matured area. Sabah is still the largest oil palm planted state with 1.54 million hectares or 27.4% of total planted area. (See Table 1)

Crude palm oil (CPO) production recorded a marginal increase of 1.5% to 19.96 million tonnes in 2015 compared with 19.67 million tonnes in 2014. The increase was attributed to improved FFB yield in Peninsular Malaysia and overall increase in matured planted area. There was a dismal drop of oil extraction rate (OER) yield by 0.8% nationwide. The average OER dropped to 20.46% in 2015 compared with 20.62% in 2014. The industry is still a long way from achieving a targeted FFB yield of 26.2 tonnes per hectare and OER of 23% by 2020 under the NKEA on palm oil. (See Table 2)

Total exports of palm oil increased marginally by 0.8% to 17.45 million tonnes while palm kernel oil decreased by 4.5% to 1.07 million tonnes in 2015. Overall, the total exports of palm oil, palm kernel oil, palm kernel cake, oleochemicals, biodiesel and finished products showed an increase of 1.2% largely driven by better export volume of palm oil, biodiesel and palm kernel cake. The high carry-over stocks, high imports and marginal increase in export demand had contributed to high palm oil stocks during the year. The weak supply and demand fundamentals had further dampened palm oil prices which contributed to relatively low export earnings in 2015. (See Table 3)

India continued to be the Malaysia's largest palm oil export market in 2015, importing a total of 3.68 million tonnes or 21.1% of total palm oil exports, followed by the European Union (EU) at 2.43 million tonnes (13.9%), China PR at 2.38 million tonnes (13.6%), Pakistan at 727,610 tonnes (4.1%) and the United States (USA) at 703,482 tonnes (4.0%). These five countries imported a total of 9.93 million tonnes or almost 57% of total Malaysian palm oil export in 2015. (See Table 5)

Overall there was a major decrease in palm oil export to many traditional export markets. Malaysian palm oil exports to China PR, Egypt, Iran, Singapore and Pakistan showed a drastic decline. Palm oil exports to China PR decreased by 19.3% to 2.38 million tonnes from 2.89 million tonnes in 2014. This was mainly due to cost competitiveness and higher import of Indonesian palm oil. Domestically in China PR, there are higher imports and stock availability of soya and rapeseed beans for domestic processing which further dampened the overall vibrancy of the Chinese market demand. Export of palm oil to Iran declined by 35.1% to 330,930 tonnes from 447,058 tonnes in 2014 due to a silent limit (of 400,000 tonnes) imposed on palm oil import by the Iranian authorities. Iran imported a total of 635,258 tonnes of Malaysian palm oil in 2013 thus a major loss to the market if the silent limit is not lifted. The USA imported 703,482 tonnes or a decline of 11.3% from the high of 783,105 million tonnes in 2014. The Trans Pacific Partnership Agreement (TPPA) which was concluded in 2015 is expected to create more market access for Malaysian palm oil to the USA once it is ratified. (See Table 5)

Export of palm kernel oil decreased by another 4.5% to 1.07 million tonnes in 2015 from 1.12 million tonnes in 2014. In 2013, Malaysia exported 1.17 million tonnes of palm kernel oil. Over the years, there was an overall decline in the competitiveness of Malaysian palm kernel products. PORAM has lobbied for the removal of 5% export duty imposed on RBD palm kernel oil in order to spur more value added export. The Government has agreed to study PORAM's proposal again on this long standing issue. (*See Table 3*)

The average CPO locally delivered price in 2015 was much lower at RM2,153.50 per tonne compared to the average of RM2,383.50 in 2014. As a result, the average export prices for major processed palm oils were also affected, namely RBD Palm Oil (FOB) at RM 2,279.50 per tonne and RBD Palm Stearin (FOB) at RM2,058 per tonne. The price of RBD Palm Olein dropped considerably to RM 2,289 per tonne or an average of RM205.50 from RM2,494.50 in 2014. The by-product, Palm Fatty Acid Distillate (PFAD) was traded the lowest at RM1,902.50 from RM 2,269.50 per tonne in 2014. (See Table 4 and Table 6)

The average price for locally delivered crude palm kernel oil (CPKO) also dropped by 3.6% from RM3,497.50 per tonne in 2014 to RM3,373 per tonne in 2015. (See Table 4)

In 2015, palm oil opening stocks increased again to 2.63 million tonnes compared to 2.02 million tonnes in 2014 and 1.99 million tonnes in 2013. The higher overhanging stocks did not go well with export demand in 2015 which had resulted in weaker off-take and dampened prices of all major palm oil products throughout the year. (See Table 2)

As at December 2015, a total of 55 refineries were in operation with a total annual refining capacity of 26.94 million tonnes. Two more refineries were shut-down in 2015 due to unfavourable economic competitiveness. The refining utilisation rate was 63.6% compared with 64.7% in 2014. The refining utilization rate has been dropping gradually over the years despite the closure of two refineries in 2015. This is partly due to the imbalance of supply and demand of CPO in the country. The refining margins have fluctuated substantially over time against a tough landscape and operating environment. There is a need for a very comprehensive government policy and transparency to review the refining licensing policy in the country taking cognizance of the existing excess capacity situation and the temporary suspension of palm oil import introduced in the last quarter of 2015. (See Table 7, Table 8 and Table 9)

There was a huge surge of CPO exports amounting to 5.27 million tonnes in 2015 largely due to zero export duty as a result of lower CPO gazetted prices (except in April 2015) compared to 4.70 million tonnes in 2014. The newly introduced US\$50 per tonne levy on CPO and between US\$10 to US\$30 per tonne levy on processed palm oil (PPO) in Indonesia effective 15th July 2015 have largely eroded Malaysian refiners' competitiveness when CPO price is below RM2,250 per tonne FOB in Malaysia for the remainder of the year. This has resulted in a shift in Malaysian exports towards CPO thus reducing the processing and value addition of Malaysian palm oil products. PORAM has appealed to the Government to review the CPO export duty structure to be in line with that of Indonesian's. (See Table 10)

The Government imposed a temporary suspension of palm oil import in October 2015. As a result, there was a squeezed in the supply of palm oil in the country. PORAM made a representation to the ministry to remove the temporary suspension in order for the trade to flourish. Member who have committed themselves in a long term contract for import were allowed to continue import.

The lack of export competitiveness has reduced Malaysian palm oil exports from producing and exporting PPO to CPO. In the last five years, the amount of CPO export has been averaging around 25% of the total palm oil export. In 2015, a total of 5.27 million tonnes or 30% of CPO was exported. There is a dire need for objective government policy to support the competitiveness of the refining industry by increasing the availability of CPO in the country and facilitating more processing and value addition.

C. LIAISON AND CONSULTATION WITH THE GOVERNMENT

PORAM continues to have an excellent rapport and cooperation with the Ministry of Plantation Industries and Commodities (MPIC) and other Government agencies. PORAM and its Members supported and participated in various meetings and activities conducted by MPIC, Ministry of International Trade and Industry (MITI), Ministry of Finance (MoF), Royal Malaysian Customs Department (RMCD), Malaysian Palm Oil Board (MPOB) and Malaysian Palm Oil Council (MPOC).

I. Ministry of Plantation Industries and Commodities (MPIC)

MPIC has been supportive of PORAM's interests. Throughout the year, PORAM had participated in several meetings conducted by MPIC on:

PORAM has been supportive of MPOB in various programmes organized throughout the year namely the Palm Oil Familiarization Programme (POFP); MPOB International Palm Oil Conference (PIPOC); MPOB TAS Interaction Session with the Malaysian Palm Oil Industry; MPOB Transfer of Technology; MPOB Oil Palm Products Surveying Course and National Seminar on Palm Oil Milling, Refining, Technology, Quality and Environment (POMREQ). PORAM contribution was in terms of members' participation, in organising committees and presentation of papers at some of the events.

III. Malaysian Palm Oil Council (MPOC)

Over the years, both MPOC and PORAM have been forging regular cooperation and interaction with one another especially on market development and promotional activities. Members have been kept informed about palm oil market development through various publications disseminated by MPOC. The Council was a sponsor at PORAM's Annual Dinner 2015 and provided assistance to PORAM in organizing the Malaysian Palm Oil Industry Golf Challenge 2015.

PORAM was actively consulted by MITI and had attended several meetings/dialogues on:

- Trans-Pacific Partnership Agreement (TPPA)
- Free Trade Areas (FTAs)
- ASEAN Trade in Goods Agreement (ATIGA)

V. Ministry of Finance (MoF) and Royal Malaysian Customs Department (RMCD)

The Goods and Services Tax (GST) was implemented on 1st April 2015. PORAM has engaged several meetings, consultations and discussions with MoF and RMCD on the implementation of GST treatment on palm oil products. A Task Force on GST was established to identify and outline areas of concern which may affect the overall performance of the palm oil trade when implementing GST as well as providing solutions to overcome these concerns. The Secretariat has also conducted two surveys on "GST Submissions and Refund" and the findings were shared with the government to overcome any delays in refund.

D. LIAISON WITH INTERNATIONAL AND LOCAL ORGANIZATIONS

In order to keep abreast with developments within the vegetable oils and fats industry, PORAM has been maintaining a close working relationship with several organizations both locally and internationally.

PORAM is actively involved in the activities of the Federation of Oils, Seeds and Fats Associations Limited (FOSFA International). The Association continues to monitor the discussion and the development of sustainable palm oil. PORAM also attended a meeting on ASEAN Sustainable Palm Oil Standard workshop organized by ASEAN Vegetable Oils Club (AVOC) in Kuala Lumpur in June 2015.

PORAM continues to maintain a close working relationship with the Palm Oil Millers Association of Malaysia (POMA), Malaysian Edible Oil Manufacturers Association (MEOMA), Malaysian Palm Oil Association (MPOA), Malaysian Estate Owners' Association (MEOA), East Malaysia Planters' Association (EMPA), Malaysian Oleochemical Manufacturers Group (MOMG), Malaysian Biodiesel Association (MBA) and Malaysian Oils and Fats Technologists Association (MOSTA). PORAM was also consulted in the formation of the newly set-up Malaysian Palm Oil Certification Council (MPOCC).

For the sixth year running, Bursa Malaysia Derivatives (BMD) was the Titanium sponsor for the PORAM Annual Dinner and a contributing supporter of the PORAM Annual Forum 2015. For the fourth time, Exim Bank remained the Gold sponsor of PORAM Annual Forum 2015 and presented a paper on "EXIM Bank: Your Palm Oil Trade Partner".

During the year, PORAM presented the following papers;

I. COMMERCIAL AND TECHNICAL COMMITTEE

A total of three scheduled Commercial and Technical Committee (C&T) meetings were held during the year in March, June and August 2015. Representatives from the Malaysian Palm Oil Board (MPOB) and Malaysian Palm Oil Council (MPOC) attended these meetings regularly on the invitation of the Committee. Their respective participation is important particularly to update the Committee on new research developments, regulatory, environmental, market promotions and market issues. At the same time, both MPOB and MPOC were briefed on issues of concern affecting the progress of the industry that could be taken up and addressed by their respective agencies.

En. Haja Mansoor was appointed as the Vice Chairman of Commercial and Technical Committee and effectively as Chairman of Technical and Educational Working Group (TEWG) on 2nd June 2015.

Minutes of each meeting were distributed to all Members of the Committee and matters of importance were referred to the Management Board.

Following are some of the important subject matters deliberated by the Committee during the year:

a. RBD Palm Kernel Oil Export Tax Structure

MPOB has finalised the study on 'The Removal of 5% Export Tax on RBD Palm Kernel Oil" as proposed by PORAM. The result of the study was presented to the Committee with mixed review. The study was not comprehensive as PORAM, MEOMA and MOMG views were not included in the study. It was suggested that MPOB to conduct the study with proper consultation with the respective industry members and not based purely on export data and statistics. MPOB agreed to complete the study and present their report by the first quarter of 2016.

b. Goods and Services Tax (GST)

A number of issues are still outstanding and have remained unresolved even after various meetings and consultations with RMCD. It was agreed that all unresolved issues pertaining to GST matters should be tackled one at a time to elicit a positive response from the Government. The first important outstanding issue to overcome is the subject on 'String Contracts' which has become problematic in the trading of palm oil products from one party to another whereby a string is created. PORAM had requested for strings contract to be zero rated.

c. Task Force on Improving Competitiveness of Malaysian Palm Oil Industry

A brainstorming session was convened on 15th December 2015 to come up with a blueprint to enhance the competitiveness of Malaysian palm oil exports. Some of the issues discussed included temporary suspension of palm oil import; CPO export tax structure; removal of 5% export tax on RBD PKO; refining policy; TPPA; and GST. It was agreed that a Task Force be formed to look into some important topics and to suggest recommendations/proposals to increase the export volume of Malaysian palm oil and counter stiff competition from Indonesia. The proposals will be presented to MPIC for their considerations.

d. Malaysian Sustainable Palm Oil (MSPO) Requirements for Palm Oil Refineries

The latest draft document prepared by MPOB with regard to Malaysian Sustainable Palm Oil (MSPO) Requirements for Palm Oil Refineries was finalised by the Technical Working Committee on 24th November 2015. The draft was circulated for members' comments and feedback. The final draft will be tabled for an adoption at the National Committee in the first quarter of 2016.

e. Trans-Pacific Partnership Agreement (TPPA)

That TPPA has been finalized pending approval by Parliament. Once approved in January 2016, Malaysia will have about 2 years to ratify the agreement. Under TPPA, Malaysia is allowed to maintain CPO export tax structure but will not be allowed to impose any other duties, taxes or other charges on palm oil and products above and beyond what was agreed at TPPA.

f. Cooking Oil Subsidy Scheme (COSS)

COSS will still be in operation as the scheme falls under the total subsidy allocation in 2016. The National Budget Speech presented in October 2015 was silent on COSS. In the absence of any official written statement on COSS, members are advised that the status quo remains.

g. Council of Palm Oil Producing Countries (CPOPC)

The charter for the establishment of the Council of Palm Oil Producing Countries (CPOPC) was signed by both Malaysia and Indonesia on 21st November 2015. PORAM has been invited to participate in the work programme of CPOPC. As an Association, PORAM does not have much role to contribute in CPOPC. It was felt that CPOPC should work towards the harmonization of tariff between both countries first. This would ensure a level playing field for industry players from both countries to export more palm oil globally. PORAM position was made known to the Government.

II. ASSOCIATE MEMBERS COMMITTEE (AMC)

There was no meeting held in the year due to the on-going process to amend PORAM Rules and Constitution.

III. PRICE SETTLEMENT COMMITTEE (PSC)

There was no meeting held in the year due to the on-going process to amend PORAM Rules and Constitution.

F. TRAINING AND EDUCATION

Following were courses organized by PORAM and coordinated with others:

i. PORAM Operational and Commercial Aspects of Palm Oil Course

The course was conducted on 27th and 28th April 2015 at Grand Dorsett Subang Hotel, Selangor Darul Ehsan. It was attended by 120 participants from Malaysia, Singapore, Indonesia and Pakistan. The objective of the course was to provide participants with an overview on the various operational and commercial aspects related to palm oil trade and issues confronting the industry. The course gave an opportunity for the speakers to share their knowledge and experience with the participants. The course also provided an avenue for participants to network with the speakers and other members of the industry.

ii. MPOB Oil Palm Products Surveying Course

The annual event of MPOB Oil Palm Products Surveying Course was held from 26th to 30th October 2015 at Shah Alam, Selangor. PORAM was represented in the Steering Committee and Technical Sub-Committee set up by MPOB to assist in organising the MPOB Oil Palm Surveying Course. PORAM representative were also involved in presenting a paper, setting question papers, supervising the exam and marking the papers.

iii. PORAM Annual Forum

The Forum was held on 20th November 2015 at One World Hotel, Bandar Utama, Selangor Darul Ehsan. A total of 140 participants attended the event. A total of five papers were presented by five different speakers from UCSI University, LMC International Ltd, Exim Bank, Carotino and ITC Ltd, India.

G. ARBITRATION AND APPEAL

A total of 12 new arbitration cases were filed with the PORAM Secretariat between January and December 2015. The total number of cases pending as of December 2015 is 24 including 8 in abeyance.

H. PORAM WEBSITE AND FACEBOOK

PORAM website (<u>www.poram.org.my</u>) continues to serve as a major channel for disseminating market information and activities undertaken by PORAM. Continued efforts are being made to improve the functionality of the website and to provide Members with exclusive on-line resources. PORAM website is also being promoted as a branded tool to inform the public about the roles and activities of PORAM.

PORAM Facebook is an extension of on-line communication channel with Members and the public. As of 31st December 2015, the Facebook had a total of 392 registered members who were pre-screened for acceptance.
