### Challenges and Opportunities for Palm Oil in 2017 and Beyond - An Analyst Perspectives

### Palm Oil Processing: Mitigating 3-MCPD Esters and Glycidyl Esters at the Refineries

by Dr. Marc Kellens, *Desmet Ballestra, Belgium*



Marc Kellens is the global technical director of the Oils, Fats and Oleochemical division of The De Smet Ballestra Group and member of the executive committee. He is already in the De Smet Ballestra organization since more than 25 years where he in 1991 first started as manager R&D, then became in 1999 in charge of the oil refining department, and later on in 2002 also of the oilseed crushing activities. Since 2003, he is responsible, as global technical director, for the oils and oilseed technologies and oleochemical processes developed, designed and built by the De Smet Ballestra group. He carries R&D in his heart and is today still strongly involved in the new product developments and R&D activities of the group.

He has an engineering degree in food processing and technology and a PhD in oils and fats crystallization, obtained in 1984 and 1990 respectively at the University of Leuven, Belgium. He is author of numerous scientific articles and chapters in oils and oilseeds related books and has several patents in oil and oilseed processing technologies. He received in 2007 the European Lipid Technology Award and was given in 2015 the AOCOS distinguished Oil processing division award.

He was president of the European Federation for the Science and Technology of Lipids, better known as Eurofedlipid, a federation of 13 scientific associations in Europe concerned with Lipids, Fats and Oils, from 2010 till 2013.
